### Nontank Vessel

- Invoiced upon request or automatically when vessel enters State waters within the ACN coverage area, including unlimited transits and operations. Invoice provides rolling 365 days of compliance from invoice date.

### Tank Vessels and Tank Barges

- Operating Tank vessels
  - » Coverage rate includes State and Federal APC coverage.
  - » Operating Tank vessels with a total oil capacity of over 500 barrels will be invoiced upon each entry in Western Alaska Captain of the Port Zone.
  - » Billed upon nomination and/or entry into Western Alaska Captain of the Port Zone, invoiced annually for calendar year coverage ending on December 31st.
- Tank Barges – Billed upon annual nomination for calendar year coverage ending on December 31st. Members may request to pay in quarterly installments, which do not equate to separate compliance coverage terms. All quarterly installment payments are applied to the total annual invoiced dollar amount, as nominated by the member.

# 2024 Vessel Coverage Fee Schedule

## General Information

## Key Definitions

**Nontank Vessel (NTV):** A self-propelled vessel that does not carry oil or fuel in bulk as cargo under state or federal regulations.

- Operating: A vessel stopping to conduct any cargo operation or commercial activity within State of Alaska waters (excluding Southeast Alaska). Operating vessels over 400 GRT require State compliance.
- Transit Only: A vessel passing through the WAK and/or PWS COTPZ without stopping to conduct any operation or commercial activity in the WAK and/or PWS COTPZ and is sailing to or from a U.S. port. Transiting vessels greater than 400 GRT or 400 ITC, whichever is greater, require Federal compliance.

**Tank Vessel (TV):** A self-propelled vessel that carries oil and/or refined products in bulk as cargo that operates in state or federal waters, or both, that requires oil spill compliance.

- Operating: A vessel stopping to conduct any cargo operation or commercial activity within the WAK COTPZ (outside of Cook Inlet), whether inside or outside State of Alaska waters.
- Transit Only: A vessel passing through the WAK COTPZ without stopping to conduct any operation or commercial activity within the WAK COTPZ and is sailing to or from a U.S. port. Tankers that transit WAK COTPZ that are calling ports in Cook Inlet only are considered Transit-Only vessels. A vessel passing through the PWS COTPZ, more than 50 nautical miles offshore, without stopping to conduct any operation or commercial activity within the PWS COTPZ and is sailing to or from a U.S. port.

**Tank Barge:** A vessel that is not self-propelled that carries oil or refined oil in bulk as cargo and requires state and/or federal oil spill compliance.

**Total Oil Capacity:** The total maximum amount of oil or refined products that can be stored in either fuel tanks or cargo tanks in a Vessel – commonly referred to as Worst Case Discharge (WCD). The Capacity is reported for each vessel seeking oil spill compliance coverage.

**ITC:** International Tonnage Certificate, means the gross tonnage measurement of the vessel under the Convention Measurement System.

**GRT:** Gross Register Tonnage, means the gross tonnage measurement of the vessel under the Regulatory Measurement System.
