The Alaska Department of Environmental Conservation (department) has completed its review of the Streamlined Plan Cleanup Contractor Registration application that was received on 12/15/2020. The department reviewed the application for compliance with 18 AAC 75.561. The department has determined that your **amendment** application is consistent with the applicable requirements of the referenced regulations and is hereby approved for registration as Cleanup Contractor in the state of Alaska for:

- Nontank Vessels  Noncrude Oil Tank Vessels & Barges

The attached certificate registers you to serve as a Streamlined Plan Cleanup Contractor for the following regions of operations(s) as defined in 18 AAC.495 & 18 AAC.496:

This approval will remain in effect unless you request termination of your registration per the provision of 18 AAC 75.580 and it is accepted by the department or if the department, under 18 AAC 75.570, modifies or revokes this approval. No later than January 31 of each year, under 18 AAC 75.561, a Cleanup Contractor shall provide to the department a complete list of streamlined plans in which the Cleanup Contractor has agreed in writing to be listed as the Cleanup Contractor. In accordance with 18 AAC.565, the department may conduct announced and unannounced discharge exercises to ensure that a nontank vessel cleanup contractor is adequately prepared to act in the event of a spill. No more than two exercises will be required for a cleanup contractor in each 12-month period.

Registration of a Cleanup Contractor by the department does not constitute an assurance by the department of the qualifications or abilities of that contractor or that the contractor will adequately respond to a release or threatened release of oil, nor does it provide a defense to liability under state law (18AAC 75.510(b)).
